## What is Wrong with the Legal System, and Where does Academia Fit In?

The world of academic research is focused, by its nature, on theoretical and abstract questions. The academic researcher is not supposed to serve directly any social or governmental institution or system. But does this mean that the academic researcher is absolved of any commitment to the promotion of the values and institutions of the society in which she lives? What, in particular, is the role of academy with regard to the legal system? To what extent is the academic research and discourse relevant to the real problems of contemporary legal systems? The annual conference of the Israeli Law and Society Association (ILSA) will be devoted to the discussion of these questions.

The Program Committee of the conference invites scholars of all disciplines to submit proposals for organized panels that will be devoted to the main theme of the conference – What is Wrong with the Legal System, and Where does Academia Fit in?

Possible panel topics include: the congestion of the courts, judicial legitimacy, alternative dispute resolution, the workings of the prosecution and of the criminal system, competing narratives regarding the legal system, and more. The committee is also initiating particular panels on relevant topics, including: the privatization of the legal system, empirical studies of the legal system, procedural access to justice,

constitutional dialogues and notwithstanding power, the legal system and disempowered segments of society, the legal system and the media, legal education and legal practice, the flooding of the legal profession, publication policy of court decisions. Panels will be held either in Hebrew or in English.
