# **RCSL ELECTION RESULTS**

In April 2000, 429 members in good standing received ballot materials. By June 5, 150 ballot sheet were received at the IISL in Oñati. The count, performed under the supervision of the IISL director, Pierre Guibentif, produced the following results (ratified by the RCSL Board on 9 July 2000):

# CHANGE OF STATUTES APPROVED

The changes in the RCSL statutes were approved by a vote of 137 for approval and one vote against, with 11 abstentions and one invalid vote (Total = 150). The new version of the by-laws (reprinted in the last Newsletter) shall come into effect on January 1, 2001. The new Statutes will be published again in the next RCSL Newsletter.

# **MEETING OF THE NEW BOARD**

In its first meeting, on 9 July 2000 in Oñati, the new Board has elected the following persons to form the executive Board:

- two vice-presidents (David Nelken and Ann Boigeol)
- the secretary (Hector Fix-Fierro)
- two more members of the executive Board (Masayuki Murayama; David Trubek).

The criteria used to reach this decision were the proportion of votes received together with the wish to provide geographical and linguistic representation. The meeting recalled the possibility under the Constitution of co-opting further members "in order to extend RCSL activities in specific areas or to take care of specific activities" (part 5.4 of the Statutes). The president is asked to approach possible representative from Africa.

#### **OÑATI IISL**

Pierre Guibentif completed in July 2000 his successful two-year term as Oñati director. He was lauded by the new RCSL president as having consolidated the work of his predecessors. His linguistic abilities enabled him to communicate easily with all parts of the socio-legal community. In addition he was able to strengthen relations with the Basque government and the University of the Basque country. A comprehensive report on the 10-year history and work of the Institute has been edited by him and will be available in the four official languages of the IISL (Basque, English, French and Spanish). Guibentif will be succeeded in September 2000 by a duumvirate consisting of Bill Felstiner (USA) and Manolo Calvo Garcia (Spain), which is scheduled to last for three years. For the first half of this term Felstiner will be the official Director, while Calvo will serve as his Vice Director. After eighteen months they will change roles.

But these are not the only role changes with respect to the IISL: on becoming Director of the IISL, Bill Felstiner resigned as IISL Board member and was replaced by Rogelio Perez Perdomo, whose place in turn was taken over ex officio by the new RCSL President Johannes Feest.

#### Working Groups

For the renewal of present working groups as well as for the acceptance of new ones an advisory committee was constituted. It will give an opinion until the end of the year. Meanwhile all WG chairs will remain as members of the RCSL Board.

#### RCSL BUDGET

The RCSL secretary reports that the average yearly income from membership fees amount to about 3500 EURO = US \$. Recurring expenditures stem from the twice-yearly publication of a newsletter (about 300-400 EURO per issue) and the RCSL's contribution to the Treves grant for a scholarship Since an appeal to members has raised so far only 600 EURO, the RCSL will have to contribute the balance of 2400 EURO. This means that the RCSL comes precariously close to the limits of its financial possibilities.

It was agreed that in the future all persons who are not paid up RCSL members will have to pay an extra fee when attending annual meetings. The Board also studied a proposal to introduce the following new fee structure, based on the ISA model of three levels depending on the GNP of the country of residence:

countries A: 160 EURO = US \$

- countries B: 80 EURO = US \$
- countries C: 40 EURO = US \$

Students pay 50 percent. Waivers can be granted by the RCSL secretary. In the case of members from countries C, applications for waiver are automatically granted. ISA members, who have to pay higher fees anyway continue to pay 40 EURO/US \$.

After discussion, the Board decided that the proposal should be presented to the membership via the Newsletter, making clear the reasons for extra funds. A Board decision is scheduled for the next Board meeting, July 2001 in Budapest.

#### **RCSL ANNUAL MEETINGS**

Together with the Spanish Association for the Analysis of Law and Society (DyS) the RCSL has held its annual meeting in July 2000 in Oñati. The meeting was attended by over 100 scholars from 20 countries. It was the first almost truly bilingual annual meeting (i.e. without simultaneous translation): some of the sessions were held in English, others in Spanish, some alternating between the two languages. The next annual meeting will be held, jointly with the Law & Society Association, July 4-7 2001, at the European University in Budapest.

In 2002 our annual meeting will be, July 8-12, in the context of the World Congress of the International Sociological Association in Brisbane, Australia.

#### **OÑATI ESSAY PRICE**

In the context of the RCSL annual meeting in Oñati, the results of the third edition of the Essay price competition were announced. This time the work of George Gurvitch had been the topic of the competiton (see Oñati Newsletter 10, Winter 99/00). In an anonymous procedure, the three referees

(Jacques Commaille; Vittorio Olgiati and Paavo Uusitalo) agreed unanimouly to give the price to a paper entitled: "Integrating Reciprocal Perspectives. On George Gurvitch's Theory of Immediate Jural Experience". The essay turned out to be written by RCSL member Reza Banakar (Oxford), who happened to attend the meeting and was given deserved ovations by the multinational audience.

Last years price (focussing on Leon Petrazycki) went to RCSL member Kasia Dzerniczewska (Warsaw). In its first year, the competition was won ex aequo by Julio Avalos (now Caracas) and RCSL member Pompeu Casanovas (Barcelona) with essays on Vilhelm Aubert.

Publication of the essays is underway.

## **BUDAPEST 2001: CALL FOR PAPERS AND MORE**

Preparations for the next annual meeting (Budapest. July 4-7, 2001) have already started. All WGs of the RCSL are asked to attend and run sessions. As usual, individual papers are also welcome and will be assigned to sessions by the program committee (please contact the RCSL president or secretary; addresses on first page of this Newsletter). In addition, it was agreed to launch Collaborative Research Networks (CRNs), as a way to bring scholars from the two Associations together and thereby facilitate international research collaboration in selected topics for presentation at the meeting in Budapest in July 2001. The CNRs met twice at the LSA meeting in Miami Beach. They will continue their work, primarily by electronic means, between the 2000 and 2001 meetings. Additional CNRs can still be set up. While CNRs include scholars from all parts of the world, participation of some scholars from Central/Eastern Europe and Latin America were assisted by a two-year grant to the Association from the National Science Foundation and support from the American Bar Foundation. Funds from the NSF grant will again be used to support the travel of a limited number of scholars from those geographical regions to Budapest. Additional efforts at fund-raising to expand the travel support available are ongoing.

## FLORISA VERUCCI (+ APRIL 2000)

The RCSL is mourning the death of another one of its members. Florisa, a lawyer and women's rights activist in Brazil, has also been very active in the WG on Gender Equality. Her latest book publication came out in November 1999 (Da mulher em mutacao). A great number of her earlier publications (some in Portuguese, some in English) can be found in the IISL library/Centre of Documentation. She has been a leading figure in feminist politics in Brazil. She acted as a counsellor for the Ministry of Justice and was the only female member on the important Committee of experts on constitutional law during the period of transition from military regime to democratic rule and civil government in the early 1980ies.
