PRESIDENTIAL ADDRESS

As it has been announced in previous RCSL Newsletters, in the course of the year 2012 our Committee has been officially involved, among a number of other activities, in the organization of, and participation in, three remarkable joint international events: the RCSL- LSA joint Congress on "Socio-Legal Conversations Across a Sea of Islands", held in Honolulu, USA on June 5-8; the II ISA World Forum with RCSL Sessions on "The Quest for Justice and the Limits of the Law", held in Buenos Aires, Argentina, on August 1-4; the RCSL 50th Anniversary Celebration Conference, held in Warsaw on October 19-21. Reports about the above mentioned first two events have been already provided and said in previous Newsletters. The report about RCSL Jubilee Celebration is included here. In this respect, let me outline two scanty considerations to stress the highly symbolical and cultural relevance of the celebration of the RCSL Jubilee.

As we all know we are living in a period of extraordinary social and legal epochal changes that compell us to continuously reflect - and from now on even more so - not only on current state-of-the-art of law-policy making, official institutions' performances, legal professions' restructuring, academic education reforms, etc., but also, and increasingly, upon the "rationale" of the historical epistemic foundations of our disciplinary fieldwork and the historical paths that these foundations entailed and still entail.

At the same time, due to the extraordinary development of socio-legal studies and research particularly in the last fifty years - we are now provided with a quite large number of valuable theoretical insights and empirical sources, the nature and amount of which, however, can hardly be comparable and coherently systematised (due, among other things, to the on-going fragmentation of socio-legal contexts and the deepening of sociolegal complexity) unless a leading cognitive/reflexive guidance is provided.

Given the above, the historical and symbolical importance of the celebration of the RCSL Jubilee at

the University of Warsaw this year cannot be ignored or underestimated, as it offered us, as RCSL members as well as the whole ISA community, an unique and higly remarkable opportunity: to rescue and re-actualize early rooths and scientific imprinting of Sociology of Law as still highly usefull theoretical and methodological grids for future disciplinary achievements that will certainly stem from the new Socio-Legal Centres and Associations that have been recently set up by new generations of scholars in many countries of the world.

2013 JUAN CELAYA GRANT

The 2013 winners of the Juan Celaya Grant are Dorothy Estrada Tanck (Human Security and Transnational Social Networks: claming the rights of undocumented migrant women and girls) and lagê Zendron Miola (Notables of law and economics: clashes and consensus between lawyers and economists in the import and practice of antitrust policy in Brazil – 1994/2011).

RCSL JUBILEE MEETING – WARSAW (2012)

Despite several important socio-legal meetings already on 2012 agenda, about 50 scholars, mostly from Europe but not only had gathered in October at University of Warsaw in order to commemorate the 50th anniversary of the establishment of Research Committee of Sociology of Law at ISA. Though none of the original founders - William Evan, Adam Podgórecki and Renato Treves – are alive, they were present as subject of many commemorative speeches and academic papers. Preceded by the official opening speech by acting President of RCSL Vittorio Olgiati, the first session was devoted to the history of the RCSL as recollected in the memory of long standing members of the Committee of various generations - Jean van Houtte, Vincenzo Ferrari, Kurczewski, Jacek Mavis Maclean, Jerzy Kwaśniewski, Stefka Naoumova, Klaus Ziegert, Anne Boigeol and Adam Czarnota. Anne Boigeol has presented RCSL Podgórecki's Prize to two young scholars – Fatima Kastner from Hamburg, Institute for Social Research, was awarded for her work on systems theory and commission on truth and reconciliation, while Stefan Larsson, from Lund University, for his research on law and digital communication. The session was concluded with welcoming speech by Jennifer Platt vice-president of ISA. The commemorative toasts were also made at the evening Gala Dinner in Warsaw Actors' Club.

The next day sessions focused on two of the founding persons - Renato Treves and Adam Podgórecki and selected topics of their interest. Session dedicated to memory of Treves was titled "Administration of Justice in Liberal Democracy" and included on the one hand the description of Treves' personality and academic work made by his student Valerio Pocar and on the other, the further analysis of issues in administration of justice as encountered today in democratic Italy (Anna Rosa Favretto on judicial ideology of family judges and Fernando Spina on judicialization of politics) and in democratic Poland (Treves' influence on Polish studies on administration of justice in times of democratic reconstruction as described by Stanisław Tyszka and Grażyna Skąpska on her recent study of administration of justice).

Session on Totalitarian Law and Transitory Justice was devoted to memory of Podgórecki and included several papers dealing with the issue so important in his writing. It was started by Susan Karstedt, who dealt with the rule through law as opposed to the rule of law in totalitarian context. Jiří Priban developed his paper referring to Podgórecki's notions of "dirty togetherness" and "totalitarian Grundnorm". Jerzy Kwaśniewski continued the criticism with which Podgórecki met the post-1989 developments in Poland claiming that the totalitarian legacy had not been yet eliminated, while Małgorzata Fuszara presented the fundamental change in the criminal policy comparing the communist and democratic Poland. Iwona Jakubowska-Branicka referred to the Podgórecki's seminal study of "Prestige of law" published in 1966 and later replications showing complexity of the public opinion trends on the law within totalitarian and democratic context. Finally, Adriana Mica pointed to the use of scandals and communist party moots as the para-legal way of diverting conflict under the communist rule in Rumania.

The evening special session was devoted to the assessment of the project of empirical sociological theory of law as developed by Adam Podgórecki. Paper given on that subject by Jacek Kurczewski was supplement with comments by Mark Cooney, who presented the Donald Black's "pure sociology" perspective on law as the alternative.

The last third day of conference included two special sessions and two open sessions. Edoardo Fittipaldi had presented his new book, Everyday Legal Ontology. A Psychological and Linguistic Investigation within the Frame of Leon Petrazycki's Theory of Law, 2012 (Edizioni Universitarie di Lettere, Economia, Diritto LED) developing some ideas of Leon Petrażycki's theory of law and legal semiotics and logics. The book had been commented by Polish scholars Krzysztof Motyka and Jan Winczorek and afterwards Fittipaldi was awarded by the Foundation of Institute of Applied Social Sciences, University of Warsaw the distinction Pro Sapientia Cum Virtutis Praescriptis Adequata in recognition for his contribution to developing and disseminating Petrażycki's ideas. Maria Ausillia Simonelli presented the first treatise on sociology of law published in Italian as Sociologia Giuridica. Contributo (Torino, Fratelli Bocca, 1907) by Carlo Nardi Greco. This presentation based upon a book by Simmonnelli (Alle origini della sociologia del diritto in Italia. L'opera di Carlo Nardi-Greco, 2004, Napoli: La Città del Sole) was commented by Vincenzo Ferrari and Maria Rita Bartolomei.

In the open sessions the topics were as usual multiple and therefore papers difficult to summarize. One important stream was the assessment of the development of sociology of law, either with focus on historical origins or on present issues (Hakan Hyden on pioneers in Nordic sociology of law, Dace Sulmane on Latvia, Germano Schwartz with Dani Rudnick and Renata Almeida da Costa in Brazil, Anuradha Parasar with Meenakshi Sharma in India and Takayuki li in Japan) . Jan Winczorek , Paola Ronfani with Roberta Bosisio, Stefka Naumova, Anna Krajewska, Pierre Guibentif, Aleksandra Niżyńska, Adriana Mica, Paweł Kociszewski, Stefan Larsson, Flora di Donato with Francesca Scamardella and Adam Czarnota gave papers on legal education, procedural rules, homoparental families, anti-discriminatory regulation, financial crisis and tax avoidance, formality versus informality in house heating readaptation. methodological innovations and digital technology in relation with law and sociology of law.

Selected papers from the conference are to be published in a special volume of Societas/Communitas, the bi-annual journal of the Institute of Applied Social Sciences, University of Warsaw, edited by Jacek Kurczewski and Vittorio Olgiati. The Institute directed by Małgorzata Fuszara had been co-hosting the meeting organized jointly with RCSL ISA and managed by Aneta Gawkowska and Anna Krajewska, members of the RCSL from Warsaw.

RCSL BOARD MEETING – WARSAW (2012)

In the course of the RCSL Jubilee Meeting at Warsaw it was conducted the RCSL Board Meeting. Some points were discussed and among them it can be stressed the following ones:

a) The Podgórecki 2013 Comisssion nominated during the II ISA World Forum in Buenos Aires, Argentina, was confirmed and will start to work immediately (Robert Van Krieken - Vice-President ISA, Suzana Karstedt, Angélica Cuéllar Vázques)
b) RCSL is fully committed with the 2013 RCSL-IEP Joint Meeting in Toulouse (3-6, September, 2013).
c) Luigi Cominelli is in charge of the revision of the POCL Statute as required by ICA. Comments Schwarts

RCSL Statute as required by ISA. Germano Schwartz will help him in this task.

d) The 25 years anniversary of Oñati will happen in 2014 and RCSL will support the IISJ in everything they need to accomplish an outstanding academic event.

e) The RCSL 2015 meeting will occur in the city of Canoas, Brazil, being hosted by Centro Universitário Unilasalle.

RCSL STATUTE REVISION

As pointed out earlier, ISA has demanded to RCSL a revision of its Statute. According to the RCSL Board decision, this task is in charge of Prof. Luigi Cominelli, RCSL's Vice-President. Germano Schwartz, current RCSL Secretary, was indicated to help him in order to write a draft that must circulate among RCSL's members before August, 2013. The deadline to end the revision is the 3 of September, 2013. The final decision will be made in the course of the RCSL-IEP Joint Meeting in Toulouse, France, from 3-6, September – 2013.

PODGÒRECKI PRIZE

Call for Nominations: ISA RCSL Podgòrecki Prize 2013.

The ISA Research Committee on the Sociology of Law established the Podgòrecki Prize in 2004, to honour the memory of Adam Podgòrecki, the founding father of RCSL and a leading figure within the international sociological community.

A jury of RCLS, chosen by the RCSL President, awards the prize annually for outstanding achievements in socio-legal research, in alternate years for either distinguished and outstanding lifetime achievements, or outstanding scholarship of a sociolegal researcher at an earlier stage of his or her career.

The prize for lifetime achievements will be awarded as an honorary prize, symbolised by a commemorative certificate, to honour outstanding and exemplary colleagues who have produced guiding and inspiring work. The prize for emerging socio-legal scholars will be a commemorative certificate and a money prize, to honour and encourage colleagues that have yet to leave a mark on the international level of production of socio-legal research but who have published one or more significant works within no later than 10 year of his or her doctorate.

Call for 2013 nominations

The ISA RCSL Jury Committee for the Podgòrecki Prize calls for nominations for the Senior Prize, which will be awarded in 2013 to a socio-legal scholar for their outstanding lifetime contribution to socio-legal scholarship and research. Previous winners of this prize have been 2011: David Nelken (Italy), 2009: Boaventura de Sousa Santos (Portugal), 2007: Richard Abel (USA) and Vincenzo Ferrari (Italy), 2005: Erhard Blankenburg (The Netherlands).

Nominations require the support of at least two members of the RCSL, and should include the candidate's CV and a brief letter of support from each nominator. It is desirable, but not essential, that nominees are members of RCSL. Previous nominees may be re-nominated in this 2013 round, with updated letters and CVs.

Publications can be in any language. For works in languages other than those familiar to the Prize Committee, the nominations should give some indication of the value of the work and provide selected translations. To consider works in less wellknown languages, the Jury Committee can co-opt and consult other RCSL members.

Award of the Podgoreki price.

Anne Boigeol

RCSL has established the Prize in 2005 to honour the memory and life-time scientific achievement of Adam Podgòrecki, (one of the Founders of RCSL and a leading figure within the international sociological community), who is honoured today, at the RCSL Jubilee.

The Prize is awarded annually to socio-legal scholars in recognition of their contributions to the development of the discipline. It is awarded every alternate year, to a distinguished scholar in recognition of his/her outstanding contribution in the field of sociology of law, and to an emerging scholar to reward his/her promising work in the disciplinary fieldwork.

This year, the Podgòrecki Prize has to be awarded to a young socio-legal scholar. The RCSL jubilee is a wonderful opportunity for it as associates the heritage of one of the RCSL founders and the dynamism of young scholars who are developing the field of sociology of law.

The Prize committee was composed of 3 members: Professor Hyden Hakan, from Lund university, Ulrike Schultz, from Fern University, and myself, (Institut des sciences sociales du politique, Ecole normale supérieure de Cachan, (France), acting as chair woman.

We had 4 nominations : 4 excellent nominations from different parts of Europe, Spain, Belgium, Germany, Sweden. The committee had the difficult task to find the most outstanding contribution among them. We have considered 3 criteria in the evaluation of the nominates:

- the interest of the topic for the sociology of law.

- the publications.

- the insertion of the nominates in the international community.

After discussions the committee has decided that the Podgorecki Prize would be awarded to two nominates: Fatima Kastner and Stefan Larson. Before presenting them I want to mention the 2 other candidates :

Raquel Taranilla from Barcelona university, is working on a very interesting and innovative topic: legal discourse analysis with the use of linguistic tools. She uses legal language as a social fact alive.

Aude Lejeune is a social scientist dealing with law and has a Phd in social and political sciences. In her dissertation on legal aid policies and practices in Belgium and France, she focuses on the relation between legal mobilisation of law and the institutional context in which lawyers provide legal aid. She works with an interdisciplinary and compared perspective. The prize was awarded to:

Fatima Kastner. Fatima has had an international education. She has studied law, philosophy and sociology at the university of Frankfurt am Main (Germany), at the London school of Economics and the Collège international de philosophie (Paris). She has a strong interest in theory related to sociology and philosophy of law.

In her PhD, « Semantics of Powerlessness: Systems Theory and Deconstruction. On the primacy of Paradoxy in Luhmann's System theory and Derrida's Deconstruction with special reference to their autological construction of law », she has performed the extremely demanding task to confront Niklas Luhmann's systems theory with Jacques Derrida's concept of deconstruction. She gives a wellstructured, informative and expertly condensed insight into the most complex theoretical systems of two of the leading thinkers of the 20th century, working out the epistemological paradoxes.

She is one of the editors of Niklas Luhman « Law and Social System » in the English translation by Klaus Ziegert.

She has just finished another big research project: Law and Society in Transition: on the normative integration of world society, which will be her second doctorate (Habilitation). She analyzes the global proliferation of truth and reconciliation commissions and analyzes the trans-national shift from retributive to restorative justice by focusing on some questions as, for instance: why are truth and reconciliation commissions used in highly diverse settings of conflicts with marked ethnical, cultural, social and political difference.

She has written a number of articles in renown journals.

Stefan Larson. Stefan has a double training in law and sociology and a phD in sociology of law.

He is a researcher with a strong interest in internet law, the question of norms with regard to the digitalisation of society. His PhD is entitled « Metaphors and Norms. Understanding copyright law in a digital society ». He is interested in a very original question: the confrontation of the legal norms on copyright with the social norms strenght of unauthorized file sharing. Despite the decrease of unauthorized file-sharing there is always a gap between legal norms and socials norms of copyright. It is related to the fact that digitalization of society not only affects norms but also our language and mind. And he studies the way digitalization affects our language and mind through metaphors constructed from underlying conceptions.

This is a very innovative and interesting field for sociology of law. He has written a wide range of articles in high standing journals.

He is strongly involved in different programmes related to internet and digitalization in relation with norms, and sociology of law at Lund university Internet Institute, which works for a multidisciplinary approach on digitalisation.

As stipulated in the RCSL statute, Fatima and Stephan will be members of the Board, with no voting right, for 2 years.

The IISJ welcomes Adam Czarnota as the incoming Scientific Director for 2013-2015

The Scientific Directorship at the IISJ is a two year post, and so I will be returning to the Law School at Flinders University at the end of August 2013. The incoming Scientific Director has been confirmed as Adam Czarnota.

Adam Czarnota is an Associate Professor of Law and Co-Director of the Network for the Interdisciplinary Studies of Law at the University of New South Wales, Sydney, Australia, and also a Professor of Law at the University of Bialystok, Poland. He teaches philosophy of law and sociology of law as well as history of legal and political ideas and comparative law. He has been a Fellow of the Royal Flemish Academy of Sciences and Arts, and Collegium Budapest. He has also been a Visiting Fellow and Visiting Professor in Central European University. Catholic University Leuven, Oxford University, University of Edinburgh, and the European University Institute, Florence. He has lectured at universities in Australia, United Kingdom, Belgium, Poland, South Africa and Georgia.

Adam studied law and social sciences at N. Copernicus University, Poland. He received his LLM in 1976 and PhD in law in 1982. Adam has published extensively in Polish and English in fields of sociology of law, legal theory, philosophy of law and history of ideas and political theory. Currently he is working on a book on legal strategies of dealing with the past in post-communist world and on project on law and collective memories.

Adam is already familiar with the activities of the Institute. He has taught previously on our Masters Programme, as well as attended a workshop. In addition, he has a close association with the RCSL. For instance, he has been a member of the Board of the Research Committee on the Sociology of Law and Chair of the Working Group on "Transformation of law in post-communist societies."

The second ISA World Forum was hold at the city of Buenos Aires, Argentina, from the 1st to the 4th of August, 2012. During the meeting 775 sessions were presented by 55 Research Committees (RCs). Futhermore, activities such as Work groups with paper presentations took place at the gathering. Formality and Informality from Decoupling to Entanglement Workshop on the Formal and the Informal in Law, Institutions and Economy

Polish Sociological Association in cooperation with University of Warsaw invites scholars to join in a discussion about formality and informality.

Call for Papers

The interest in the formal and the informal spans across many sociological disciplines. In organization sociology, it has been a staple topic since the dawn of the field, reflected in such themes as the limits of bureaucracy, formal/informal leadership or formal/informal information flows. In sociology of law, the issue of informal working of legal institutions has also been a core problem, contributing to the very institutionalization of sociological studies of law, as opposed to lawyers' inquiries in its formal nature. Similarly, economic sociology has long been interested in investigating the exchange processes in informal economies, and the subtle relationships they

have with the official ones. The Workshop intends to bring together these diverse interests and discourses and by doing so, to facilitate the confrontation of their theoretical assumptions and the empirical outcomes they produce. It should not escape notice that many recent contributions to that theme, particularly in organization sociology and institutionalism, have broken with depicting informal institutions as mere epiphenomena of formal structures to explore the dynamics of the formal and the informal as selfcontained realms. In this perspective, the interest is focused on the manner in which informal practices support, confront and oppose the formal sphere of conflicting logic. One impulse for such reorientation has been the interest in the formal in the studies of diffusion and institutional isomorphism, as well as decoupled and loosely coupled systems. Interestingly, this shift parallels earlier developments in sociology and anthropology of law, stressing the impossibility of purely formal, zweck-rational legal institutions and underlining the immanence of legal pluralism. In all said fields, the research topics converge, comprising such phenomena as: formal and informal constraints, rules and regulations, processes of formalization and de-formalization, informal exchanges in formal systems, formal and informal organizations in markets, ethnic economy and entrepreneurship and, lately, formalization of informal practices and transnational governance. In line with these developments, the Workshop welcomes papers dealing with such topics as:

- Interactions of the formal and the informal in institutions and legal systems;
- Emergence, development and dissolution of formal organizations in the informal contexts;
- Formal management of informal pressures and informal incapacitation of formal norms and restraints;
- The role of social capital in formal social systems;
- Informal economy and the relation it bears to formal economy.

The Organizing Committee hopes the Workshop will contribute to the conceptual and theoretical enrichment of the studies of the informal and the formal, create an apt platform for revisiting well established assumptions and paradigms, and help opening new research sites for empirical investigation. Selected papers will be invited for publication in a themed volume.

REPORT ABOUT 3RD ABRASD CONGRESS CURITIBA – UFPR

The 3rd ABRASD Congress was hold in the city of Curitiba, in the state of Paraná, Brazil, at UFPR (Universidade Federal do Paraná). It was a complete success. With over 555 registered and 167 presented papers - surpassing the numbers of 2012, the event promoted several activities, including workshops, working groups, cultural events and dialogues related to multiple themes on sociology of law. It has been decided, at the event, that the next meeting will take place in September, 2013, in the city of Recife, state of Pernambuco, Brazil, at the UFPE (Universidade Federal de Pernambuco). A new board of directors has been elected. The new president is Marcelo Mello (UFF), the first vice president is Artur Stamford (UFPE) and the second, Germano Schwartz (Unilasalle/FSG).

NEWS FROM "Gender, Law and Society" RCSL Working Group

Since October 2012 the Gender and Law Working Group's Chair is shared by two junior scholars, Alexandrine Guyard-Nedelec (University of Cergy-Pontoise, France) and Barbara Giovanna Bello (University Statale of Milano, Italy). On behalf of the RCSL, they wish to thank the former Chair, Prof. Rosemary Hunter, for her dedication and passionate work for eight years, during which the activities of the Working Group flourished. While the new chairwomen plan to continue the activities in line with the approach adopted until now, which focuses on the gendered nature of law and the legal construction of gender, they also aim at broadening the scholarly agenda and scientific programme of the Working Group, which is now called "Gender, Law and Society". Taking as a starting point the laws in their contexts, the Working Group aims at providing space for reflections on issues such as the gender consequences of law in a global world, the intersections between gender and other grounds defining identity, as well as other new or updated approaches to gender coming into being (e.g. transnationalism, super-diversity, etc.). More specifically, among the questions of the working group are those concerning how gender is implicated in globalization processes, how migration processes are gendered and what gendered effects result from these processes; how gender interplays with other grounds in shaping the experience of women belonging to different kinds of minorities (ethnic and religious minorities, LGBTs, disabled women, migrant groups, etc.); how women and men shape their relations in today's fluid societies. Additionally, the Working Group aims at promoting a debate to move towards an enlarged notion of gender, which embraces different gender identities arising from gender reassignment as the preamble of the Recast Directive 2006/54 suggests.

The WG's first activity scheduled for 2013 is the workshop "Gender renewal(s)?" at the International Congress "Sociologie du Droit et Action Politique", jointly organized by the ISA/RCSL 2013 and SciencePo Toulouse, - which will take place in Toulouse on September 3-6, 2013. Congress of the Swiss Sociological Association Inequality and Integration in Times of Crisis June 26 – 28, 2013, University of Bern

Since Karl Marx first described the enormous social inequalities and their potential for social change at the beginning of industrialization in the 19th century, the origins, extent, and consequences of social inequality, as well the level of inequality which a society is willing to tolerate, have been major themes in sociology. The SSA Congress will take on the theme of inequality in multiple areas ranging from research on unequal educational and labor market opportunities, unequal income distributions, gender and health inequality, and inequality in life expectancy, to mention only a few.

In particular, the economic crisis at the start of the 21st century underlines the fact that the theme of inequality has not lost its relevance. Above all, the European debt crisis inclines us to suspect that social inequality is growing. At the same time as inequalities within European societies are exacerbated, disparities between states are also rising, which will likely have adverse effects on European unification, not to mention creating new challenges for Switzerland as well. The inequality effects of economic and demographic changes will lead to an increase in migration and elevate the immigration pressure on the European Union and Switzerland. For this reason, Switzerland, as well as the other European countries,

grapple with questions of managing migration and integration.

Inequalities – as problematic they may be – are also in some sense an opportunity. They increase the diversity of society and can bring about new ideas, innovation, and growth. Our desire and ability for social integration depends, above all, on the ultimate balance between these advantages and disadvantages. Within the framework of the various foci, the conference will concentrate on the opportunities as well as the risks associated with these social changes.
