#### PRESIDENTIAL ADDRESS

Last year has been really an extraordinary year for our Research Committee: the year of its Jubilee.

The RCSL 50th Anniversary Celebration, held in Warsaw, has been not only a highly relevant symbolic act, but also the occasion to provide now insights about its historical foundation and the subsequent development of sociology of law as a worldwide international scientific community. The papers that have been presented in the course of the event have been collected and are now under editing.

At present another important issue is on the agenda: the joint ISA-RCSL / SciencesPo Toulose International Congress on "Sociology of Law and Political Action" that will take place in Toulouse, France, from the 3rd to 6<sup>th</sup> of September. Three meetings have been held in Toulouse by the Steering Organization Committee and the final result is quite extraordinary indeed, as you can see in this Newsletter.

In spite of current economic crisis that prevents, in particular, young scholars to afford the travel's costs, equally relevant results have been achieved so far as regards the active participation of RCSL at the forthcoming ISA World Congress that will be celebrated in 2014 in Yokohama, Japan, thanks to the valuable commitment of our Japanese colleagues.

All the above has been made possible by the rising interest that our discipline is gaining within and outside the scientific community. Indeed, due also to the general conditions of the international socio-legal "climate" never before we have witnessed to the rise of such an amount of new research centres, new sub-disciplinary fieldworks and new lines of enquiry.

Interestingly, these achievements are, by rule, related to changes occurring in newly developed countries: a fact that will certainly bring new lights on the everlasting relationships between social and legal systems.

#### FORMALITY & INFORMALITY CALL FOR DISCUSSION & PAPERS WORKSHOP

Formality and Informality from Decoupling to Entanglement: on the Formal and the Informal in Law, Institutions and Economy UNIVERSITY OF WARSAW 13-14 y 2013

Polish Sociological Association in cooperation with University of Warsaw invites scholars to join in a discussion about formality and informality. The interest in the formal and the informal spans across many sociological disciplines. In organization sociology, it has been a staple topic since the dawn of the field, reflected in such themes as the limits of bureaucracy, formal/informal leadership or formal/informal information flows. In sociology of law, the issue of informal working of legal institutions has also been a core problem, contributing to the very institutionalization of sociological studies of law, as opposed to lawyers' inquiries in its formal nature. Similarly, economic sociology has long been interested in investigating the exchange processes in informal economies, and the subtle relationships they have with the official ones. The Workshop intends to bring together these diverse interests and discourses and by doing so, to facilitate the confrontation of their theoretical assumptions and the empirical outcomes they produce.

It should not escape notice that many recent particularly contributions to that theme, in organization sociology and institutionalism, have broken with depicting informal institutions as mere epiphenomena of formal structures to explore the dynamics of the formal and the informal as selfcontained realms. In this perspective, the interest is focused on the manner in which informal practices support, confront and oppose the formal sphere of conflicting logic. One impulse for such reorientation has been the interest in the formal in the studies of diffusion and institutional isomorphism, as well as decoupled and loosely coupled systems. Interestingly, this shift parallels earlier developments in sociology and anthropology of law, stressing the impossibility of purely formal, zweck-rational legal institutions and underlining the immanence of legal pluralism. In all said fields, the research topics converge, comprising such phenomena as: formal and informal constraints. rules and regulations, processes of formalization and de-formalization, informal exchanges in formal systems, formal and informal organizations in markets, ethnic economy and entrepreneurship and, lately, formalization of informal practices and transnational governance. In line with these developments, the Workshop welcomes papers dealing with such topics as

- Interactions of the formal and the informal in institutions and legal systems;
- Emergence, development and dissolution of formal organizations in the informal contexts;
- Formal management of informal pressures and informal incapacitation of formal norms and restraints;
- The role of social capital in formal social systems;
- Informal economy and the relation it bears to formal economy.

The Organizing Committee hopes the Workshop will contribute to the conceptual and theoretical enrichment of the studies of the informal and the formal, create an apt platform for revisiting well established assumptions and paradigms, and help opening new research sites for empirical investigation. Selected papers will be invited for publication in a volume.

#### international conference WOMEN AS JUDGES: PATHS, EXPERIENCES AND REPRESENTATIONS LISBON - PORTUGAL June 18 th 2013

In the last decades, a significant transformation of legal professions has been its increasing feminization. These numbers, as well as the growing role of some female magistrates, have attracted the attention of the media and of some sectors of the judiciary. However, if in other countries we can find studies on this fact, in Portugal this analysis has not yet been performed, so that interpretation on the feminisation of the judiciary leads back, mainly, to the increasing number of women in the profession still relying on speculation and often in stereotypes. In this scenario a question becomes eminent: when it comes to the feminisation of the judiciary, does one seek to reflect only the increase in the number of women in the judiciary or on the contrary, is it possible to speak about a different way to apply law and do justice marked by a gender perspective? This conference is intended to understand whether there is a real feminisation of justice, established not only in quantitative but also qualitative terms, and whether it contributes to the

emergence of a new legal culture. The conference, organized by the Centre for Social Studies, will have as presentators Ulrike Schultz, Vittorio Olgiati and Anne Boigeol, Madalena Duarte among other academic and legal professionals.

### ONATI-IISL International Congress on Gender Violence

From 10<sup>th</sup> to 12<sup>th</sup> July, the IISL hosted an international congress on gender violence. The congress is aimed at examining the usefulness of gender as main conceptual framework for thinking about gender violence, and papers will also examine the intersection of gender violence with other determinants of inequalities.

The congress has been organised by Angela Melville (International Institute for the Sociology of Law); Ana Isabel Pérez Machio (Universidad del País Vasco); Arantza Campos (Universidad del País Vasco) and David Gadd (University of Manchester).
